

# Mandurah Basketball Association

## 2020 AGM Nomination for Board of Directors

We invite eligible members of MBA to nominate for Board of Director positions. Please refer to the relevant Director Position Descriptions. The current Board of Directors encourages you to consider the duties contained within, your suitable experiences, your ability to strengthen the Association and the estimated time commitment required.

**You may nominate for more than one position.** However, a separate completed nomination is required for each position. Senior positions (President or Vice President if applicable) elections will occur first during the AGM. The remaining positions elections order will be determined by the Board and stated on the Notice of AGM, Agenda, available on Thursday 8<sup>th</sup> September, 2020.

Under section 39 of *the Associations Incorporation Act 2015*, the following persons must not act as a Director of a management committee of an Association:

- A person who is, according to the *interpretation Act 1984* section 13D, a bankrupt or person whose affairs are under insolvency laws;
- A person who has been convicted, within our State of –an indictable offence in relation to the promotion, formation or management of a body corporate; or an offence involving fraud or dishonesty punishable by imprisonment for a period of not less than three months; or an offence under Part 4 Division 3 or section 127 of the Act.

Section 39 only applies to a person who has been convicted of the above offences only for period of 5 years from the time of the person's conviction, or if the conviction results in a term of imprisonment, from the time of the person's release from custody.

- **All nominees are required to provide a current National Police certificate with this nomination form. A National Police Certificate is available from <https://www.nationalcrimecheck.com.au> Cost for a volunteer is \$29.90.**
- **Your nomination must be endorsed by a current eligible financial member of the Association.**
- **Your election to the Board is subject to compliance with Association rules and agreement to a MBA Board Code of Conduct.**
